THE FESTIVAL IS ALWAYS HELD THE THIRD WEEKEND OF AUGUST.

**FOOD VENDOR FEE IS \$255.00+ELECTRIC FEE OF \$45.00=\$300.00 TOTAL**

APPLICATIONS MUST BE COMPLETE AND RETURNED WITH FEE BY JUNE 20th. LATE FEE IS \$25.00.  
\*\*NO VEHICLES, CARGO TRAILERS OR RVs WILL BE ALLOWED TO PARK IN OR BEHIND SPACES.\*\*  
\*\*\*ONLY YOUR CONCESSION STAND WILL BE ALLOWED IN YOUR SPACE\*\*\*\*

### **\*\*THE FOLLOWING RULES APPLY TO ALL FOOD VENDORS\*\***

ALL NEW FOOD VENDORS' APPLICANTS MUST FURNISH INSIDE AND OUTSIDE PICTURES OF THEIR CONCESSION.  
ALL FOOD VENDORS MUST SUPPLY THE CHAMBER WITH A CERTIFICATE OF LIABILITY INSURANCE NAMING THE CHAMBER AS A CERTIFICATE HOLDER AND MUST HAVE A TEXAS FOOD MANAGER CERTIFICATION. (CALL 903-628-6702 FOR INFORMATION OR LOG ONTO [www.Learn2Serve.com](http://www.Learn2Serve.com))

FOOD VENDORS WILL BE LIMITED IN NUMBER AND THE DUPLICATION OF MENU ITEMS AS DECIDED BY THE FOOD CHAIRMAN.

NO FOOD ITEM MAY BE SOLD THAT IS NOT LISTED ON THIS APPLICATION AND APPROVED.  
NO SELLING OF ANYTHING OUTSIDE OF YOUR CONCESSION. DO NOT EXCEED YOUR SPACE LENGTH OF 25 FEET.

THERE WILL BE NO DUPLICATIONS OF THE MAIN MENU ITEM FOR EACH VENDOR.--EACH FOOD VENDOR WILL HAVE THE EXCLUSIVE RIGHT TO SELL THEIR MAIN FOOD ITEM. LIST YOUR PREFERENCE FOR YOUR MAIN FOOD ITEM FIRST ON YOUR MENU BELOW.

ALL FOOD VENDORS MUST HAVE A CURRENT BOWIE COUNTY TEXAS FOOD HEALTH PERMIT.  
CONTACT THE BOWIE COUNTY HEALTH INSPECTOR AT THE BOWIE COUNTY COURTHOUSE AT 903-628-6833 TO MAKE ARRANGEMENTS FOR THE INSPECTION AND PERMIT. (THERE IS A FEE.) THIS MUST BE DONE BEFORE YOU CAN OPEN FOR BUSINESS. (HE HAS BEEN INSPECTING ON FRIDAY AFTER THE FEE IS PAID UNLESS YOU PLAN TO OPEN EARLIER.)

ELECTRICITY AND WATER ARE INCLUDED. VENDOR MUST FURNISH THEIR OWN HOSE AND CORD WITH PLUG(RANGE PLUG FOR 220 VOLT OR A REGULAR THREE PRONG FOR 110 VOLT)

VENDORS ARE RESPONSIBLE FOR THEIR OWN SALES TAX COLLECTION/PAYMENT.

FOOD VENDORS MUST BE SET UP BY FRIDAY BY 6:00PM. VENDORS MAY SET UP & OPEN AS EARLY AS WEDNESDAY OR THURSDAY. THE CARNIVAL STARTS WEDNESDAY NIGHT!!!

ANY VENDOR MAY BE EXCLUDED FOR CAUSE DEEMED NECESSARY TO INSURE THE QUALITY OF THE FOOD VENDOR AND THE SAFETY OF THE PUBLIC. ANY VENDOR NOT ADHERING TO THESE RULES MAY BE ASKED TO CLOSE AND LEAVE THE FESTIVAL GROUNDS.

NO WASTE GREASE OR FOOD PRODUCTS ARE TO BE DUMPED OR LEFT AT THE FESTIVAL SITE. PLEASE TAKE IT WITH YOU.
