I attest that the information provided is true and accurate. I agree to comply with the New Boston, Texas Farmers' Market Rules and Regulations and Requirements for Food and Produce Vendors, as well as all applicable guidelines as specified by state and federal guidelines. I understand that failure to do so may result in revocation or suspension of the permit/application.

The permit/application is effective for Farmers' Market Season 2022 unless revoked for a cause.

The permit is not transferable and must be available on site each Market day.
